**RESOLUTION AUTHORIZING ADVERTISEMENT FOR RECEIPT OF BIDS FOR THE LEASE OF CERTAIN BOROUGH-OWNED REAL PROPERTY (BLOCK 163, LOT 15 & 16.01) FOR THE USE OF CELLULAR COMMUNICATION SYSTEMS AND EQUIPMENT**

**WHEREAS**, N.J.S.A. 40A:12-14 and N.J.S.A. 40A:12-24 require public bidding when a municipality has determined to lease any real property or personal property not needed for public use; and

**WHEREAS**, the Borough of Keansburg is the owner of certain real property designated as Block 163, Lot 15 & 16.01 on the Keansburg Borough Tax Map; and

**WHEREAS**, the Borough is aware that one or more wireless communications companies have expressed an interest in leasing a portion of said property in order to occupy an existing tower and to install antennae and related equipment thereon; and

**WHEREAS**, the Borough Council has found and determined that the portion of said property is not otherwise needed for public use; and

**WHEREAS**, the Borough Council has determined that it is in the Borough's interest to grant a nonexclusive lease on the portion of said property to one or more wireless communications companies, depending upon compatibility with the Borough's needs and with the technical requirements of the tenants; and

**WHEREAS**, the use of the portion of said property by one or more tenants will not be detrimental to the portions of the public property which will continue to be used for public purposes; and

**WHEREAS**, N.J.S.A. 40A:12-14 requires advertisement and receipt of bids at public auction or by way of sealed bids; and

**WHEREAS**, the aforesaid statute allows the governing body to fix a minimum rental with the reservation of the right to reject all bids where the highest bid is not accepted.

**NOW, THEREFORE, BE IT RESOLVED** by the Borough Council of the Borough of Keansburg as follows:

1. In accordance with N.J.S.A. 40A:12-14, the Borough Clerk is hereby directed to publish an advertisement for the receipt of sealed bids for the lease of a portion of Borough-owned property designated as Block 163, Lot 15 and 16.01 on the Keansburg Borough Tax Map for the installation of antennae and related equipment onto the existing tower, subject to the terms and conditions set forth in this resolution. The advertisement shall be published once a week during two consecutive weeks prior to the date of receipt of bids, the last publication to be not earlier than seven (7) days prior to that date.

2. The minimum annual rental for each lease of space for an antenna(s) and associated equipment as specified in this resolution will be Twenty Thousand Dollars (\$20,000) per year for an initial lease term of ten (10) years with the option of renewals for two (2) successive periods of five (5) years each upon the same terms and conditions which were in effect before the end of the initial term, except as to the initial rate, which shall increase at the rate of three percent (3%) per year after the initial term. The Lessee shall enter into a co-location agreement with Crown Castle, or the successors of Crown Castle, for the right to occupy their tower.

Lessor shall be responsible for all permits and approvals, including any site plan approval as may be required for the construction and operation of the subject facilities.

3. The Borough reserves the right to reject all bids where the highest bid is not accepted and further reserves the right to award more than one lease, depending upon the needs of the Borough and the technical requirements of the high bidder or bidders.

4. Upon or before the date of the determination of the high bidder, the Borough Attorney shall prepare a detailed lease agreement which shall include all of the terms and conditions set forth in this resolution, as well as any other provisions deemed necessary by the Borough Attorney in order to protect the interests of the Borough, including but not limited to typical lease agreement provisions dealing with such subjects as use of and damage to the property, insurance coverage in favor of the Borough, access to the leased premises, standard representations of the Borough and the lessee, maintenance and repair, default and right to cure, assignment and sublease, notices, applicability of Federal and State laws and regulations, determinations and responsibilities with respect to interference, and payment of utility costs.

5. All bidders submitting bids pursuant to the advertisement shall do so with full knowledge of the requirement of a fully-negotiated lease with respect to the provisions listed in paragraph 4 above.

6. Insurance shall be provided with a minimum of a combined single limit of \$2,000,000.00 for bodily injury and/or property damage per occurrence. Coverage shall include: Commercial General Liability, Auto Liability, Property Damage and Workers' Compensation. The Borough shall be named as an additional insured on all policies.

7. All bidders shall be required to submit with each bid a certified check, cashier's check or bid bond in the amount of ten percent (10%) of the annual rental bid amount, not to exceed \$20,000 made payable to the Borough of Keansburg to serve as bid security. The bid security of all unsuccessful bidders shall be returned immediately after the adoption of a resolution granting the lease(s).

8. Acceptance or rejection of bids shall be made by the Borough Council not later than its second regular meeting following the receipt of bids. If no action is taken by the Borough Council, all bids shall be deemed to have been rejected.

**WHEREAS;** Mayor and Council have been made aware of RPM Development's interest in developing of the vacant lot, located at the corner of Beachway and Raritan Avenues (196 Beachway), more specifically known as Block 15, Lot 1; on the tax maps of the Borough of Keansburg, commonly known as the "Kontos Property"; and

**WHEREAS;** Mayor and Council fully support this development initiative as such development would be beneficial to the Borough and support the Borough's economic development efforts which would produce various construction jobs and new permanent jobs via the proposed commercial component in the mixed-use development as well as the addition of new tax ratables; and

**WHEREAS;** The Borough sustained substantial damage and devastation to its tax base as a result of Super Storm Sandy; and

**WHEREAS;** It is the Borough's understanding that, based on schematic plans presented by the developer, the project as currently envisioned includes a mix-of-uses, within a proposed 4-story structure, including residential dwelling units (1, 2 and 3 bedroom units) and commercial/retail space, and a multi-story parking deck; and

**WHEREAS;** The project is expected to bring new business activity as well as an increase in customers to support such activity; and

**WHEREAS;** The Borough supports this initiative and seeks to encourage County and State Agencies to join in its support for the purposes of the economic growth within the Borough as well as the entire region; and

**WHEREAS;** The Borough encourages and endorses an application by RPM Development to the State of New Jersey or any other funding opportunity for public funding to assist and to make possible the project as proposed; and

**WHEREAS;** The subject property previously had received major site plan approval from the Borough and said project was unable to move forward, leaving the subject property vacant and unproductive; and

**WHEREAS;** the Borough seeks support of this proposed development from any and all other public and private entities having interest in economic development throughout the Bayshore area of Monmouth County and the broader region; and

**ORDINANCE #1562 – Retail Hours Restrictions**

AN ORDINANCE AMENDING AND SUPPLEMENTING CHAPTER XXII (DEVELOPMENT REGULATIONS), SECTION 5.9 (REGULATIONS CONTROLLING THE B-1 GENERAL COMMERCIAL ZONE DISTRICT) AND SECTION 5.10 (REGULATIONS CONTROLLING THE B-2 (MIXED USE COMMERCIAL-RESIDENTIAL ZONE DISTRICT) OF THE REVISED GENERAL ORDINANCES OF THE BOROUGH OF KEANSBURG.

BE IT ORDAINED by the Mayor and Council of the Borough of Keansburg as follows:

Section 1: Permitted Uses and Structures in the B-1 (General Commercial Zone District) and B-2 (Mixed Use Commercial-Residential Zone District) Zones of the Borough of Keansburg shall be subject to the following restriction:

4. Retail trade limited to the following:

(a) through (h) and (j) through (p): Hours of operation shall be limited to 5:00 a.m. to 1:00 a.m.

Section 2: REPEALER. The remainder of all other sections and subsections of the aforementioned ordinance not specifically amended by this Ordinance shall remain in full force and effect.

Section 3: INCONSISTENT ORDINANCES. All Ordinances or parts thereof inconsistent with the provisions of this ordinance are hereby repealed as to such inconsistency.

Section 4: SEVERABILITY. If any section, paragraph, subdivision, clause or provision of this ordinance shall be adjudged invalid, such adjudication shall apply only to the section, paragraph, subdivision, clause or provision so adjudged and the remainder of this ordinance shall be deemed valid and effective.

Section 5: EFFECTIVE DATE. This ordinance shall take effect upon its passage and publication according to law.
