ORDINANCE #1503 – Landlord Registration Fees

AN ORDINANCE AMENDING AND SUPPLEMENTING CHAPTER XI (BUILDING AND HOUSING) SECTION 4.1 (RENTAL PROPERTY REGISTRATION REQUIRED) AND SECTION 4.2 (LICENSING)

BE IT ORDAINED by the Mayor and Council of the Borough of Keansburg that Section 4.1 entitled Rental Property Registration Required and Section 4.2 Licensing of Chapter XI (Building and Housing) of the Revised General Ordinances of the Borough of Keansburg are hereby amended and supplemented as follows:

- Section 1: Section 4.1 “Rental Property Registration Required” *shall read:*
- a) The owner of every rental property, with the exception of owner-occupied units, in the Borough of Keansburg shall file a Rental Registration Statement Properties vacant or available for sale shall also be subject to file Rental Registration Statement.
 - b) The Rental Property Registration Statement shall be filed on an annual basis on or before March 1 of each year after which time a late fee shall be assessed.
- Section 2: Section 4.2 “License Required” *shall read:*
- b) 1. No person(s), corporations or business entity shall rent, lease or let any residential property to any person or persons without obtaining a license. Properties that are vacant or available for sale

are subject to said requirement. This section shall not apply to owner-occupied units.

2. The annual nonrefundable license fee shall be as follows:

Ownership of one (1) unit through nine (9) units:

Two hundred fifty dollars (\$250.00) for each rental dwelling unit

Ownership of ten (10) units or more:

One hundred fifty dollars (\$ 150.00) for each rental dwelling unit.

Ownership of rental units by a bona-fide resident of the Borough of Keansburg:

One hundred fifty dollars (\$ 150.00) for each rental dwelling unit.

For purposes of this Ordinance ownership shall mean the same individual(s), partnership, business entity or corporate name vested in the property and on the title of ownership.

For purposes of this Ordinance a bona-fide resident of the Borough of Keansburg shall be determined by the prescribed identification methods utilized and sanctioned by the Borough of Keansburg.

In the event that ownership of the property is transferred, the new owner shall apply for a license by completing a new Rental Property Registration application and submitting the applicable fee within ten (10) days of transfer or shall be subject to a late fee.

Section 3: REPEALER. The remainder of all other sections and subsections of the aforementioned ordinance not specifically amended by this Ordinance shall remain in full force and effect.

Section 4: INCONSISTENT ORDINANCES. All Ordinances or parts thereof inconsistent with the provisions of this ordinance are hereby repealed as to such inconsistency.

Section 5: SEVERABILITY. If any section, paragraph, subdivision, clause or provision of this ordinance shall be adjudged invalid, such adjudication shall apply only to the section, paragraph, subdivision, clause or provision so adjudged and the remainder of this ordinance shall be deemed valid and effective.

Section 6: EFFECTIVE DATE. This ordinance shall take effect upon its passage and publication according to law.

Whereas, NJSA 40A:11-6 provides that a purchase, contract or agreement may be made, negotiated or awarded without public advertising for bids and bidding therefore, notwithstanding that the cost of contract price will exceed the amount set in the prevailing bidding threshold, when an emergency affecting the public health, safety or welfare requires the immediate delivery of performance of services, provided:

A written requisition for the performance of such work or labor, or the furnishing of materials, supplies or services is filed with the contracting agent or his deputy in charge describing the nature of the emergency, the time of its occurrence and the need for invoking this section, certified by the officer or director in charge of the department wherein the emergency occurred, or such other officer or employee as may be authorized to act in the place of said officer or director, and the contracting agent or his deputy in charge, being satisfied that the emergency exists, is hereby authorized to award a contract for said work or labor, materials, supplies or services; and

Whereas, an emergency situation meeting the criteria set forth above a fire at Borough of Keansburg Block 184 Lot 1 (a.k.a. Kalian Property) and Block 3 and a portion of Lot 1, located on Beachway (nearest corner Oakwood Place) said work could not be
