Dear Applicant:

Regarding the above-mentioned property, please be advised that your Development Permit to construct a 12'x24' garage has been conditionally approved:

- 1. The garage and all related parts (soffit, gutter etc) is installed maintaining at least five feet (5') setback from any property line (side and rear, 25' front yard setbacks)
- 2. Maximum building height for accessory structure will not exceed 12 feet;
- 3. Obtain Construction and Flood Permits:
- 1. Additions (any new construction) must meet the yard setbacks as noted in the Development Regulations of the Borough of Keansburg.

I have also included a second page of information that you may need to include in your notices should you wish to appear before the Board.

If you wish to pursue this application you are directed to the Keansburg Planning Board of Adjustment for a formal hearing to grant the necessary variances which would be needed to permit the construction and for final approvals. - 22-7.3e Restoration of a Nonconforming Building or Structure any Nonconforming structure that has been more than partially destroyed must be rebuilt in conformity with the current zoning regulations.
- 22-5.2c No existing building or structure shall be moved, altered, added to or enlarged, nor shall any land or building or portion of a building or structure to be used, designed, or arranged to be used for any purpose unless in conformity with all of the regulations herein specified for the district in which it is located.
- 22-7.3c Nonconforming Uses, Building or Structure. No nonconforming use may be expanded.

- 1. Construction and repair of sidewalks, curbs, and driveways. 2.11;
 - c. Driveways and parking areas must confirm to specifications of a minimum with of nine (9) feet and minimum length of eighteen (18) feet. The apron and depressed curb are not to be considered as part of the driveway unless approved by the Planning Board of Adjustment.
 - d. Vehicles shall not be parked on any front lawn without site approval from the Planning Board of Adjustment.
- 2. 22-9.3a(5) Off-Street Parking.
 - a. The driveway measures a minimum of thirty (30) feet in length between the garage door and the sidewalk or thirty-five (35) feet to the curb line,
- 3. Any other variances the Board may require in the course of hearing this application.
